

INDEPENDENCE PARK PAVILION RULES

PLEASE READ ALL RULES AND REGULATIONS BELOW:

1. Alcohol and illegal drugs are prohibited.
2. The pavilion must be vacated by 9:00 PM.
3. Per Ordinance NWT 2007-12, excessive noise or enhanced amplification in play, recreation and pavilion areas, exceeding requirements of the noise provisions contained in the North Whitehall Zoning Ordinance will not be tolerated.
4. Phone reservations will be accepted on a first-come, first-serve basis. The reservation form and payment must be received within 15 business days after the phone reservation and no less than 5 days prior to event. Two (2) checks are needed and both are made payable to North Whitehall Township, one for the deposit and one for the rental. The deposit check will be returned to the renter after an inspection for any damages. If no damage is reported, your check will be returned.
5. Rental fees include your clean up of area of pavilion and picnic tables. Please make sure picnic tables are in the same location that they were, prior to your event.
6. Rental does not guarantee access to the soccer and baseball fields. All prior permitted games take precedence.
7. Vehicles must be kept on designated paved areas. All vehicles are prohibited from parking or driving on the grass or the fitness track.
8. No golf is permitted in any area of the park.
9. Parents are responsible for children's behavior.
10. No campfires.
11. No Fireworks.
12. Charcoal only permitted in grills.
13. Lights are motion sensors and will turn on with motion under or around the pavilion.
14. No staples of any kind should be used on the tables or posts.
15. Beginning January 1st of each year, reservations for the pavilion will be taken for the current year.
16. Full refund of payment for pavilion **if cancellation notice is given within 5 business days of scheduled event.**
17. **NO refunds if cancellation is due to inclement weather unless the event is cancelled 5 days before as noted above in Rule #16.**

Due to unforeseen circumstances, the park may be closed down by one of the Township officials without prior notice. If possible and time allows, you will be notified.
