### WEIS GAS N' GO LAND DEVELOPMENT PRELIMINARY

Timothy Snyder, John Lerch, John Luciani, Jack O'Hara, Atty. Jim Preston, and Joseph Gurney presented the preliminary plan of the proposed Weis Land Development to the Board. Supervisor Stahley asked for a time extension offer, the applicant declined. Mr. Gurney recapped the revisions that resulted from their meeting with Township consultants on June 3<sup>rd</sup>.

Upon motion by Ronald E. Stahley, seconded by Ronald J. Heintzelman, the Plan was approved as a Preliminary subject to the following conditions:

- 1. The Developer shall comply with all of the recommendations contained in the letter from the General Planning Engineer dated June 10, 2011.
- 2. Developer shall comply with all of the recommendations contained in the letter from the Sewage Enforcement Officer dated June 16, 2011.
- 3. The Developer shall comply with all of the recommendations contained in the letter from the Zoning Officer dated June17, 2011 and the conditions placed on the Zoning Hearing Board Special Exception approval.
- 4. The Developer shall comply with all of the recommendations contained in the letter from the Traffic Engineer dated June 17, 2011.

- 5. The Developer shall comply with all of the recommendations of the Planning Commission Meetings of April 26, 2011. **NOTE:** This Plan received an unfavorable recommendation from the Planning Commission.
- 6. The Developer shall comply with all of the provisions contained in the Planning Administrator's checklist letter dated May 3, 2011.
- 7. The Developer shall contribute the cost of pre-emption equipment not to exceed \$10,000.00 to the Traffic Impact Fund in lieu of a Major Traffic Study.
- 8. The Developer shall contribute \$ 783.25 to the Recreation Fund.
- 9. The Township Traffic Engineer shall meet on site with the Applicant's Engineer to determine maximum tractor-trailer overall length to safely access the site, which shall become a condition of Plan approval. The Applicant agreed to condition 9 as stated.

Roll call: Jerry Joseph - absent; Ronald E. Stahley - yes; Ronald J. Heintzelman - yes.

- Mark Hills, Laurys Station, asked whether Weis would have to install sidewalks, noting that all stipulations imposed on Wal-Mart should be imposed on them.
- Ronald Roth, Schnecksville, asked what was the overall length of the fuel truck noted on the Plan. He wanted Weis to conduct a dry run of the fuel delivery. He voiced his concerns about safety and felt a longer truck, then what is shown on the Plan, will actually be used to deliver fuel.
- Leonard Nuss, Coplay, inquired if Weis made changes based on the Spotts, Stevens and McCoy letter of April 20<sup>th</sup> and, if changes were made, why didn't the Plan go back to the Planning Commission for review. He state the he measured Penn Tank trucks and they measure 60-65 feet in length. He also asked why the gas station wasn't planned for the other King property.
- Ronald Roth, Schnecksville, restated his safety concerns and suggested they relocate the project to the King property at Rts. 873 and 309.
- Don Travis, Slatington, asked if the township engineer had reviewed the plan calculations that Weis submitted.
- Susan Travis, Slatington, inquired what is the recourse of the township if, after everything is granted based on a smaller truck, a larger truck in used for delivery. Ms. Travis also asked the Board to consider enlarging the Board to 5 members.
- Leonard Nuss, Coplay, asked the Applicant what size truck would be used for the demonstration, he felt it should be at least 60-65 feet.
- Mark Hills, Laurys Station, stated they (Weis) should just use the truck they normally use for deliveries.
- Don Travis, Slatington, asked for clarification on truck size.
